Last day to file Petition for Opportunity to Ballot.....Midnight, Thursday, July 24, 2008  
Last day to file objections to Petition for Opportunity to Ballot .....three days after the filing of the petition\*  
Last day to file specifications of objections to Petition for Opportunity to Ballot.....Six days after filing of objections\*

\*If a Saturday or Sunday, then filed by midnight, the next Monday

Last day to institute Judicial Proceedings with regard to Opportunity to Ballot petition...Thursday, August 7, 2008 or (3) business days after BOE hearing where petition is invalidated.
